**BOARDING CONTRACT**

This is a contract between Furever Acres, LLC, D.B.A. Furever Acres K-9 Boarding, hereinafter referred to as the Kennel, and \_\_\_\_\_, of \_\_\_\_\_

with care provided by the Kennel for dates requested by Pet Owner for boarding services.

The Kennel agrees to exercise due and reasonable care, and to keep the kennel premises sanitary and properly enclosed.

The pet is to be fed properly and regularly, to be housed in clean, safe quarters, to be exercised, and to be administered any medications directed by the Pet Owner.

With due diligence and care having been exercised by the Kennel, the pet is in the Kennel's care without liability on the Kennel's part for loss or damage from disease, theft, fire, death, running away, injury, or harm to persons, other dogs, or property by said dog, or other unavoidable causes.

Pet Owner agrees to pay the Kennel the current boarding basic rate per each day for boarding services, plus any additional charges incurred according to the Kennel's policy, including Pet Owner's request for extended exercise. If it is required that a pet needs to be let outside and walked beyond the five (5) times per day allowed with the basic rate, an additional fee of \$3.00 will apply per each additional walk.

Pet Owner understands and agrees with the drop-off/pick-up charges as follows:

	<u>By 10: 30 a.m.</u>	<u>After 10:30 a.m.</u>
Drop-off:	Full day rate	1/2 of full day rate
Pick-up:	1/2 of full day rate	Full day rate

All charges incurred by Pet Owner shall be payable upon pick-up of pet.

Pet owner further agrees that their pet shall not leave the premises until all charges are paid to the Kennel by the Pet Owner or by any other person previously designated to pick up the pet.

If the pet becomes ill or if the state of the animal's health otherwise requires professional attention, the Pet Owner gives permission to the Kennel to transport the pet to the veterinarian of the Kennel's choosing, or to an emergency clinic, if deemed necessary, administer medicine, or give other required attention to the pet, the expense of which will be reimbursed by the Pet Owner at the time of pick-up of pet. Pet Owner gives permission for their Veterinarian to release medical information to the Kennel for their pet, if needed. Pet Owner also gives permission for their pet to be released to the Kennel from any authorities.
